This was necessary to protect our neighbors and save lives.

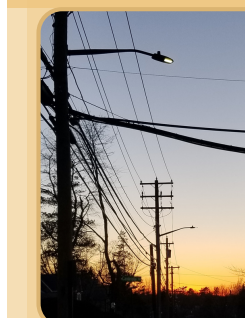

## IMPROVING THE QUALITY OF LIFE IN OUR VILLAGE

**Village furthered its mission of fiscal responsibility in the wake of the pandemic.** The Board did not raise taxes, fines, or fees. Additionally parking permits were extended without charges as to not penalize permit holders; residents, and businesses, for circumstances due to the COVID pandemic.

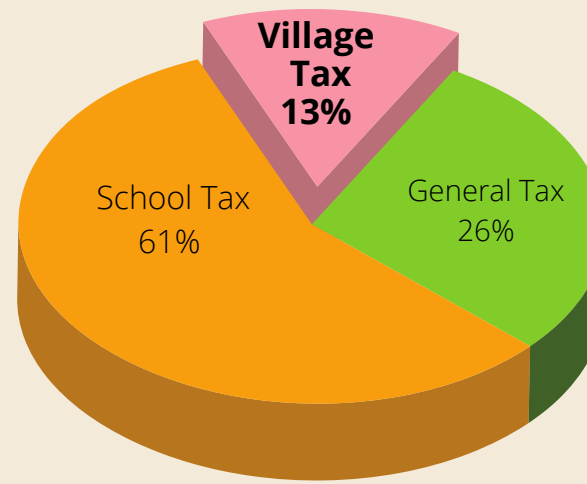
- **Village is on track to recoup capital costs of extensive Fall 2017 Village-wide LED streetlamp upgrade project by FY 2022.** The Village LED upgrade project provided technical solutions to the crucial public safety problem of poorly lighted streets, saved taxpayer money, reduced energy dependency yielding a positive effect on the environment.
- **The Village has advanced its public safety initiative.** Eight stop signs have been installed making the intersections safer. Four LED stop signs are scheduled to be installed; two on Hicks Lane at Forest Row heading east and west. The location of the remaining two is being finalized.
- **Pedestrian safety is improved** with the installation of two solar powered flashing pedestrian crosswalk signs at 533 Middle Neck Road, in both the north and south directions. This measure is being taken in anticipation of a future Nassau County street repaving project.
- **The Board of Trustees recently issued a Request For Proposals for the design and construction of a new Village Hall.** The plan is to sell our current Village Hall to the Great Neck Public Schools to relieve the overcrowding at the E.M. Baker School and build a new state-of-the-art Village Hall that will last us through the 21st century, and into the 22nd century.
- **The look and esthetic of a portion of our downtown business district has been enhanced by new storefront facades** at Marie Blachère French Bakery, Metro Florists, Everfresh, and a hybrid office/retail development at the intersection of Hicks Lane and Middle Neck Road.
- **Mayor Bral was selected by City and State NY** as they announce their 2020 Long Island Power 100 List highlighting exceptional and powerful figures in Nassau and Suffolk counties for his hard work and dedication during the global pandemic. **Mayor Bral was chosen as a Long Island Local Hero**, one of 8 Long Islanders recognized for combating the coronavirus and helping their neighbors weather the crisis.
- **Transparency in government and accessibility to government services is paramount.** The Village of Great Neck's live stream Board of Trustees meetings for the past two years made for a seamless transition when the Board of Trustees meeting went remote due to COVID. FY 2020 was the inaugural year for the tentative and final assessment rolls made available on the Village website.

## WHERE YOUR TAX DOLLARS GO

On average, only 13% of your total real property taxes are levied by the Village once a year in May.

## OUR FISCAL HEALTH IS VERY STRONG

In the Summer of 2018, Standard and Poor's, an independent, third-party bond rating agency, which assesses credit risk based on many determining factors that identify fiscal health, issued a AAA rating to the Village of Great Neck. A municipality that earns a AAA rating is viewed as possessing an extremely strong capacity to meet its financial commitments, and as a result enables the municipality to borrow at a favorable rate.

As a result, the Village took advantage of low interest rates, borrowing \$2.955 million for capital improvements as follows: \$2 million for road reconstruction, and \$955,000 for Department of Public Works equipment. The latter provided for the purchase of new bucket truck for trimming trees, and a new dump truck with plow and sanding capabilities.

As an outgrowth of the stellar AAA rating, the bond was issued at a \$56,185 premium. Subsequently during the development of the FY 2021 budget, the Board concurred to pay off the current portion of the payment due on said bond, further reducing the impact on the Village's debt service obligation by \$266,825, which is included in the appropriations.

## DEPARTMENT OF PUBLIC WORKS INVESTING IN THE SAFETY OF THE VILLAGE

The Village of Great Neck's Department of Public Works has undertaken significant projects within the Village in 2020 partly reimbursed from CHIPS, Consolidated Highway Improvement Program, a New York State grant program. Paving was completed along portions of North Road, Spring Lane, Forest Row, Weybridge Road, and Burbury Lane.

Cost savings associated with paving projects total are borne out of the Village's ability to utilize an existing Intermunicipal Agreement (IMA) with the Town of North Hempstead to take advantage of the more favorable pricing structure.

## RECYCLING

All recyclables will be collected **Wednesday** EXCEPT for the weeks that include a holiday. During those weeks, recycling will be collected Thursdays.
