Trustee Guilor-Segal moved to approve the following resolution regarding the reporting of days worked to the New York State and Local Retirement System, which was seconded by Trustee Bass and approved by all members of the Board except for Deputy Mayor Beckerman who was absent for this vote:

Reporting of Hours Worked

Be it resolved that the Village of Great Neck Board of Trustees hereby affirms and reiterates the following as a standard work day for employees and officers of the Village for the purpose of reporting days worked to the New York State and Local Retirement System:

1. Elected officials – 6 hours.
2. Full-time appointed officials; general office staff; court office staff; parking enforcement officers; sanitation staff; and building department staff – 7 hours.
3. Public works staff and water pollution control department staff - 8 hours.”
